The meeting was called to order by the Chairperson, and the roll was called showing the following Supervisors present and absent:

Motion was made by Mike Kennedy and seconded by Gayle Tellin to approve the minutes for the August 2nd, 2010 meeting. On roll call, all voted aye, none nay, and the motion was carried.

Motion was made by Gayle Tellin and seconded by Mike Kennedy to approve and sign the ACH Origination Agreement with First National Bank of West Union. On roll call, all voted aye, none nay, and the motion was carried.

Resolution # 148

24 Hour On-Call Case Management Emergency Coverage Agreement

WHEREAS, the Fayette County Board of Supervisors desires to enter into a "24 Hour On-Call Case Management Emergency Coverage Agreement" with the counties of Allamakee, Howard, Tama, Grundy, Mitchell, Chickasaw, Fayette, Dallas, Jones, and Warren; and

WHEREAS, this Resolution shall supersede Resolution # 145 dated June 28th, 2010, as the participating counties have been updated; and

NOW THEREFORE, BE IT RESOLVED by the Fayette County Board of Supervisors that they approve the proposed Iowa Code Chapter 28E Agreement that is attached herewith as Exhibit "A"; and

BE IT FURTHER RESOLVED that the Chairperson of the Board of Supervisors is appointed to execute said Iowa Code Chapter 28E Agreement on behalf of Fayette County, Iowa.

On roll call all voted aye, none nay, and the resolution was adopted.

Motion was made by Mike Kennedy and seconded by Gayle Tellin to approve the I-Jobs Small Community Water Quality Grant. On roll call all voted aye, none nay, and the motion was carried.

In other business a motion was made by Mike Kennedy and seconded by Gayle Tellin to approve the Department of Human Services property tax suspensions in accordance with Section 427.9 of the Code of Iowa. On roll call all voted aye, none nay, and the motion was carried.
