The Board of Supervisors of Fayette County, Iowa, met on November 29, 2010, at 9:00 o'clock a.m., at the Fayette County Supervisor's office.

The meeting was called to order by the Chairperson, and the roll was called showing the following Supervisors present and absent:

Motion was made by Gayle Tellin and seconded by Mike Kennedy to approve the current agenda. On roll call, all voted aye, none nay, and the motion was carried.

Motion was made by Mike Kennedy and seconded by Gayle Tellin to approve the minutes for the November 22, 2010 meeting. On roll call, all voted aye, none nay, and the motion was carried.

Motion was made by Gayle Tellin and seconded by Mike Kennedy to amend the Resolution from August 20, 2007 regarding term limits for Board appointments to state that terms previously served, and/or filling out a term for a board member who did not finish his/her term will not affect the term limit. On roll call all voted aye, none nay, and the motion was carried.

Motion was made by Gayle Tellin and seconded by Mike Kennedy to approve the following license:

The application of Thomas J. Pitz d/b/a Oran Tap and Café for a one year class "C" beer-liquor license and Sunday sales permit, including outdoor service area, for use in Oran Township was submitted and recommendation made that the license be granted. On roll call all voted aye, none nay, and the motion was carried.

The Board met with JeremWhite, Attorney for City of West Union, Bob Vagts, West Union City Administrator and Jon Biederman from Tekippe Engineering for an overview of the proposed 28E agreements for the Civic Plaza and the Geothermal Project. The Board will consider these 28E agreements at their next meeting on December 6<sup>th</sup>, 2010 at 11:00 A.M.

The Board met with Robin Bostrom and Gary Sandholm from Fayette County Economic Development with the request that the Fayette County Board of Supervisor consider adopting an ordinance that will allow the assessment of wind turbines to be reduced. They stated that this will make Fayette County a more attractive location for wind energy projects, the investment they will bring, and the taxes they will pay. The Board will consider this request in the near future.
